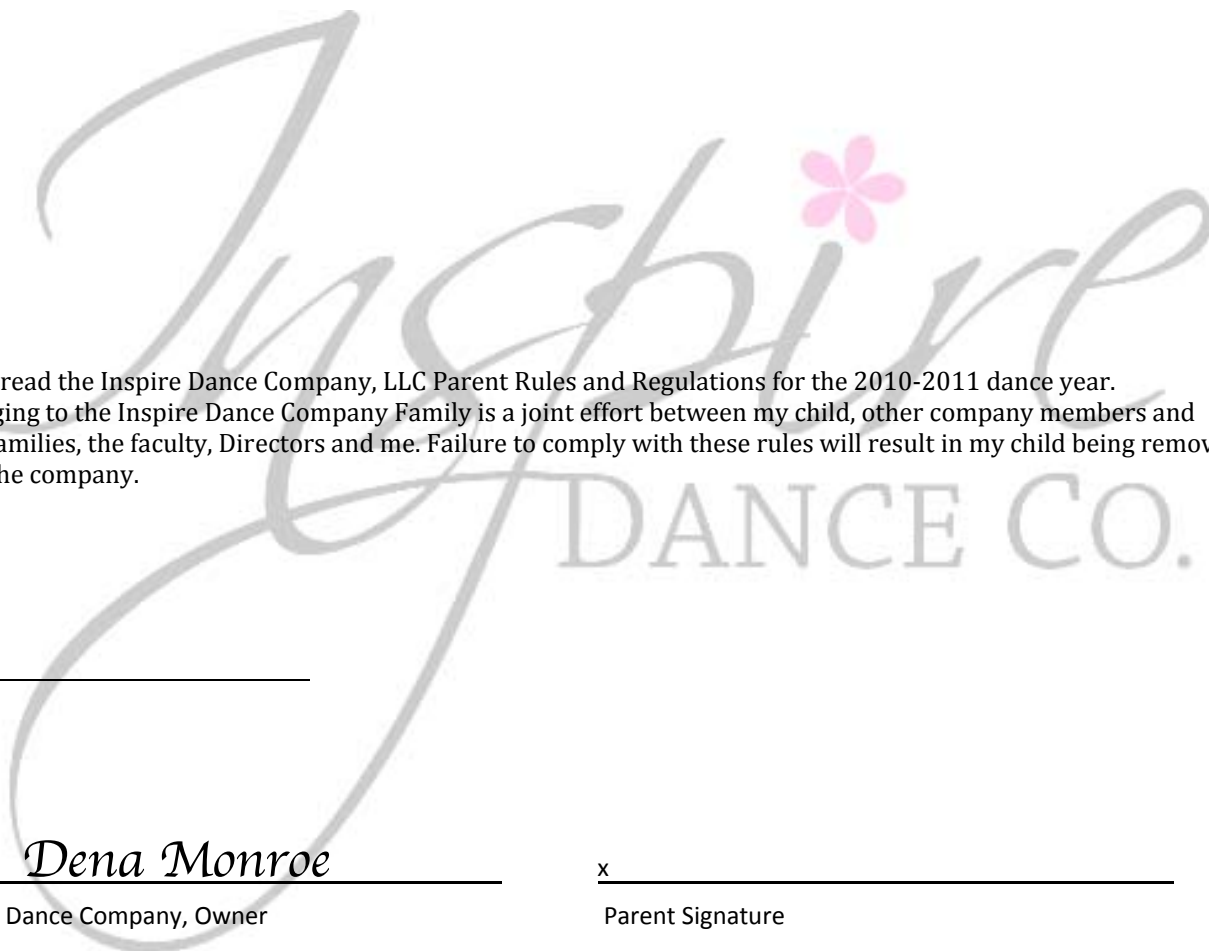
## RULES & REGULATIONS

### 2010 - 2011

1. I will remember that the primary value of dance participation is to provide our youth with an opportunity for self-development both physically and mentally.
2. I realize that as the teachers, he/she is an educator and therefore understands what he/she is teaching and the proper behavior and technique for dance class/convention/competition.
3. I understand that all decisions of placement and company pieces are at the discretion of the instructor. **I WILL NOT COMPLAIN REGARDING MY CHILD'S PLACEMENT.** I will respect the decisions made to benefit the IDC TEAM.
4. I am aware that if a parent conference is desired with the studio owner/teacher, that it is highly inappropriate to speak with them regarding this at the conclusion of an event or class. I will wait until the next day to call for an appointment with the appropriate person.
5. I recognize and respect the different roles of parents, studio owners, teachers, and judges. Parents should parent, teachers should teach, and judges should judge and each should be treated with respect for what they do.
6. I will be a positive role model at all IDC sanctioned events. I will not speak poorly of any company dance member or their families, faculty members, Directors or guest choreographers of Inspire Dance Company, LLC.
7. **It is my responsibility to make sure my child does not let other outside activities interfere with company class time or rehearsals.** I understand that this is a full year (August 2010 -June 2011) commitment for my child and me. Any extenuating family circumstances that may arise may be discussed with Miss Dena.
8. I understand that in the event of my child being absent or tardy, a phone call must be placed to the studio at 419-720-9009 and/or an email must be sent to [dena@inspiredance.net](mailto:dena@inspiredance.net) to report any absences. **Miss Dena's personal cell phone is not to be used.**
9. I agree to be at all competitions two (2) hours before my child's scheduled performance time. I understand that if I am not on time, my child may be dismissed from the number getting ready to compete. I agree to be present with my child when possible to support all Company members at competitions and conventions.
10. I will respect the judgment of the judges and refrain from openly criticizing decisions made by the judges.
11. I will help my child check costumes, jewelry, and make-up and will keep them in good condition. Failure to remember any piece of my child's costume(s) or if a costume is soiled and un-kept could result in my child not competing or performing that day. It is my responsibility to check that my child is ready for performances regardless of his or her age.
12. I am expected to attend all scheduled Inspire Dance Company, LLC parent meetings. I understand if I choose not to attend the meetings, or if I miss a meeting, I am responsible for obtaining missed information. I also realize I forfeit my right to voice my opinion or vote on issues discussed during missed meetings.
13. A negative attitude (including gossiping) amongst dancers and/or parents of Inspire Dance Company, LLC or any other studio will result in dismissal from the Inspire Dance Company.

14. All Parents/Legal Guardians of students are responsible for all fees that are incurred throughout the season. I understand that I am not allowed to disown my financial responsibilities of my child or try to get out of paying for any Inspire Dance Company fees that are due. I understand that if there is an outstanding balance on our account or if fees are due and have not been paid, my child will be asked to sit out of class and rehearsal or an event until all fees are brought current.

15. If I decide to leave the Inspire Dance Company, or if me or my child is removed from the Company, all money paid thus far will not be refunded including but not limited to registration fees, tuition, costume deposits, costumes, choreography fees, competition and convention entry fees and master workshop fees.



I have read the Inspire Dance Company, LLC Parent Rules and Regulations for the 2010-2011 dance year. Belonging to the Inspire Dance Company Family is a joint effort between my child, other company members and their families, the faculty, Directors and me. Failure to comply with these rules will result in my child being removed from the company.
